Course Description

This course examines various areas of law and their application to recreational, collegiate and professional sports. We will emphasize the legal problems and issues faced by professionals in the sport and recreation industry today. Students will utilize critical and analytical thinking to develop a basic understanding of areas of law that affect these industries.

Objectives

The objectives for the course include:

- Define with legal terms, procedures, and issues affecting the delivery of sport services.
- Describe the judicial system in the United States as it applies to sports.
- Identify and discuss litigation and legislation affecting sport organizations.
- Discuss and develop strategies aimed at reducing the probability of injuries and lawsuits surrounding sport activities.
- Analyze and evaluate the application of the law in various sport context.

Course Grading and Requirements

***Your final grade for this course is based on several categories of assignments each weighted differently and listed below.*

*Case Briefs (36%)

You must complete at least 4 cases briefs throughout the semester. During the first week of class, I will teach you how to brief a case. The purpose of the case briefs is to help students pull out the key components of a judicial decision and understand how courts interpret the law and arrive at their decisions. The assigned case for each case brief is also listed below. You’ll notice that there are 5 cases listed for case briefs, but you must only complete four. If you choose to do all 5, your lowest case brief grade will be dropped.

Case Brief 4: *Jones v. W. Va. State Board of Education*, 622 S.E.2d 289 (W. Va. 2005)

Case Brief 5: *Association for Intercollegiate Athletics for Women v. NCAA*, 735 F.2d 577 (D.C. Cir. 1984)

Quizzes (14%)

Each week students will take a short open book/open notebook quiz on the material assigned for that class. There will be 11 quizzes throughout the course, and I will drop your lowest quiz grade.

*Midterm (Short Paper) (15%)

In lieu of a midterm and final exam, students will be required to write a short paper (5 pages) based on research about a given topic covered in the course. Instructions and grading rubric can be found on Canvas.

Legal Presentation (27%)

Students will make presentations explaining how the different areas of law impact their desired positions in the sport industry. The presentation will be divided into the three parts listed below. Instructions and the grading rubric can be found on Canvas.

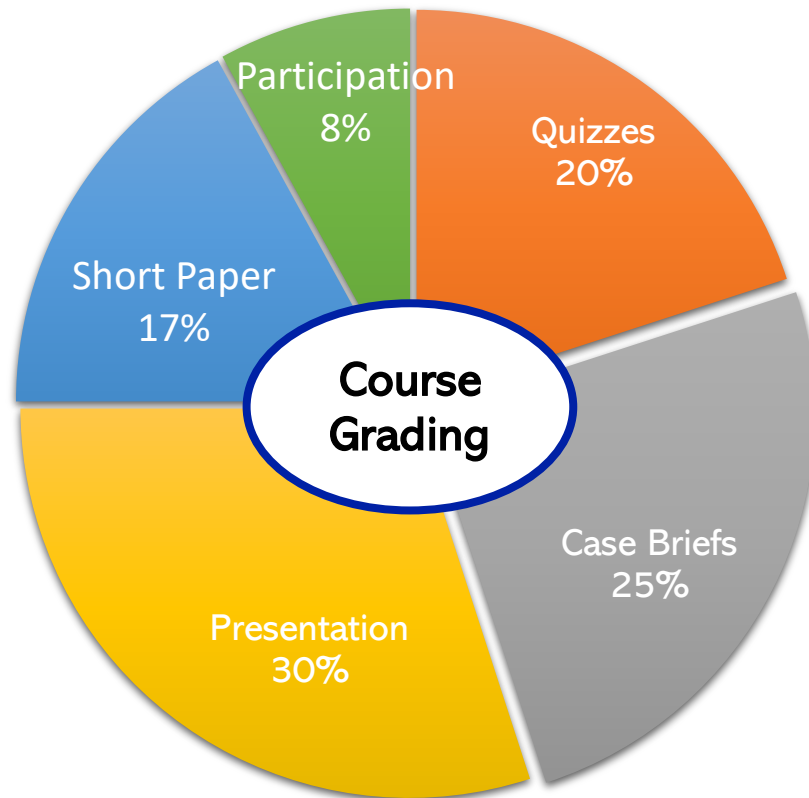

To earn full credit, you must submit questions at least 10 of 11 weeks. These questions should be used to facilitate your involvement in class discussions.
