# **COURSE DESCRIPTION**

The purpose of this Human Sexuality Education course is to acquaint students with peer-reviewed facts, issues, and research methods related to human sexuality, a topic of relevance to human rights, current events, and legal/ethical considerations. The course format will include respectful discussions, didactic instruction, expert guest lectures, and graduate student presentations. Students will have a unique opportunity to learn about human sexuality issues, increase their level of comfort with sexuality topics, and explore and clarify their personal sexual attitudes and beliefs. Guided by the instructor, graduate TA, undergraduate TAs, and several local and national experts in the field, students will be exposed to cutting-edge topics in human sexuality education. This course was developed by Dr. Sadie Sanders and adapted by Dr. Liana Hone in 2020. It was redesigned by Dr. Liana Hone in 2024.

### **CATALOG DESCRIPTION**

HSC 4133: Emphasizes peer-reviewed facts, issues, and research methods related to human sexuality. Prepares students to educate individuals and groups using evidence-based approaches. Covers theory and practice, including biopsychosocial sexual development, human reproduction, sexual relationships, legal and ethical issues, and local, national, and global current events.

HSC 5138: Additionally includes a teaching component involving designing and delivering a human sexuality education module.

### PREREQUISITE KNOWLEDGE AND SKILLS

HSC 4133: Health education and behavior majors, junior or senior standing.

HSC 5138: Not open to students who have completed HSC 4133.

### **COURSE OBJECTIVES**

### HSC 4133:

- 1. Evaluate research studies in sexual and reproductive health science areas through Canvas supplementary readings.
- 2. Examine and debate the trends and controversies within the realms of sexual and reproductive health.
- 3. Explain in depth how academics engage in sexual and reproductive health research.
- 4. Discuss the role of ethics and legal oversight and complete readings on current topics.
- 5. Identify strengths and weaknesses of qualitative and quantitative methods for addressing sexual and reproductive health issues.
- 6. Gain expertise in the major content areas in human sexuality, including sexual anatomy and physiology, sexual response, sexual behaviors and attitudes, sexually transmitted infections, sexual orientations, gender issues, and sexual coercion.
- 7. Identify personal attitudes and values related to specific sexuality topics such as gender roles and sexual orientation.
- 8. Apply critical-thinking methods to human sexuality education and research.

### HSC 5138:

- 9. Demonstrate competency in teaching one module of sex education.
- 10. Develop a lecture that addresses a sex education topic/question pertinent to the course (i.e., a chapter in the book)
- 11. Identify how your lecture as part of this course will contribute to the body of knowledge students will gain.
- 12. Evaluate the relevance and importance of your student evaluations.
- 13. Recognize the major challenges in conveying sex education topics to the general public and be able to explain how to overcome these challenges.

## **REQUIRED AND RECOMMENDED MATERIALS**

The required textbook is LeVay, S., Baldwin, J., Baldwin, J. (2020). Discovering Human Sexuality (5th ed). Oxford University Press. ISBN: 9780197522578. Additional required readings will be posted in the course Canvas page. Students can expect a variety of readings including academic journal articles, magazine and newspaper articles, and selections from popular press books. All students will need to view documents in Adobe Acrobat and develop materials in Microsoft Word and PowerPoint. ### **COURSE FORMAT**

We will meet once per week on Thursdays at 3:00 PM in Florida Gym 285 to work through course objectives. There will be differences in this meeting format week-to-week including guest lectures, documentaries, and active learning. On rare occasions, we will have online, live (Zoom) or recorded (video) lectures to accommodate expert guests from around the world. All exams and quizzes will take place online and will be open on Thursdays from 12:00 AM until Sunday 11:59 PM for you to start at any time. Once you start the exam or quiz, you will have 50 minutes to complete the test.

# Requirements

### **OVERVIEW**

To pass the course, you must attend one lecture per week and complete all activities, projects, quizzes, and exams. As described below, grades will be based on attendance, activities, projects, quizzes, exams, and participation.

## **QUIZZES (OPEN-BOOK)**

There are two open-book quizzes. Quizzes open Thursday at 12:01 AM and are due at 11:59 PM on Sundays of Week 4 and 11. Quiz 1 in Week 4 covers Chapters 1-3. Quiz 2 in Week 11 covers Chapters 9, 10, 15. Quizzes are 10 multiple choice questions, 2.5 points per question. Students will take quizzes online outside of class and are permitted to start quizzes at a time of their choosing. Quizzes are proctored by Honorlock and students will be allowed 50 minutes to complete quizzes, but be aware that late submissions (i.e., after 11:59 PM) will not be accepted. Each quiz is based solely on the facts in the book chapters that are covered in the lectures. Students **are** permitted access to materials and notes during these quizzes.

## **EXAMS (CLOSED-BOOK)**

There are two closed-book exams. Exams open Thursday at 12:01 AM and are due at 11:59 PM on Sundays of Week 8 and Week 14. Exam 1 in Week 8 covers Chapters 1-5, and 7. Exam 2 in Week 13 covers Chapters 9-12, and 15; please note Exam 2 does not cover the chapter on Sexual Violence. Exams are 25 multiple choice questions, 4 points per question. Students will take exams online outside of class and are permitted to start exams at a time of their choosing. Exams are proctored by Honorlock and students will be allowed 50 minutes to complete exams, but be aware that late submissions (i.e., after 11:59 PM) will not be accepted. Each exam is based solely on the facts in the book chapters that are covered in the lectures. Students **are not** permitted access to any book materials or lecture notes during exams.

### **ACTIVITIES**

There are 15 activities worth 8 points each. Activities are due at 11:59 PM on Sundays. Students may open an assignment as many times as desired until it is due, but late submissions will not be accepted. For most activities students will provide responses to statements. Other activities include movie and guest lecture reflections or worksheets. Activities are not specific to the book, so that need not be the primary resource. These activities are not intended to be used as a study tool for the exams. The function of the activities is to help students clarify values, beliefs, opinions, etc. Responses are confidential and there are no "right" or "wrong" answers. Grades are based on thoughtfulness, completeness, backing up opinions with peer-reviewed resources, proper APA format, etc.

## **PROJECTS**

There are two projects worth 25 points each. Projects are due at 11:59 PM on Sundays of Weeks 3 and 5. The first project is on banned books in Alachua County and the second is a Secret Intersex Documentary reaction paper. More details will be given in class and in each project's Canvas assignment. These projects are not specific to the book, so that need not be the primary resource. These activities are not intended to be used as a study tool for the exams. The function of the projects is to help you better understand sex research, local current events, and gender issues in real-life. Responses are confidential and there are no "right" or "wrong" answers. Grades are based on

thoughtfulness, completeness, backing up opinions with peer-reviewed resources, proper APA format, etc. Late submissions will not be accepted.





# **State Law Compliance**

### **STATEMENT ON HB 1557**

House Bill 1557 (Parental Rights in Education/"Don't Say Gay") was signed into law by Governor DeSantis on March 28, 2022 and prohibits classroom instruction about sexual orientation or gender identity in certain grade levels (not including universities). On Canvas, you can find the webinar created by UF's George A. Smathers Libraries and more information on what has recently been clarified.

### **STATEMENT ON HB 7**

The Florida Legislature passed House Bill 7 during the 2022 legislative session. It declares certain types of employee training and student instruction to be discriminatory as a matter of state law. Senate Bill 2524 also passed during the same legislative session, imposed large financial penalties on any university that violates the HB 7 requirements. On Canvas, you can find the webinar created by and more information on recent rulings/injunctions.

### **STATEMENT ON HB 233**

Per the House Bill 233 Intellectual and Viewpoint Diversity Act, students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor. A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session. Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

This is especially true in courses that deal with provocative or contemporary issues. UF offers many such courses, in which students encounter concepts of race, color, sex, and/or national origin. We teach these important issues because



understanding them is essential for anyone who seeks to make economic, cultural, and societal contributions to today's complex world. With this in mind, we do not limit access to, or classroom discussion of, facts, ideas, and opinions—including those that some may find uncomfortable, unwelcome, disagreeable, or even offensive. In response to challenging material, students and instructors are encouraged to ask honest questions and thoughtfully engage one another's ideas. But hostility, disruptive and disrespectful behavior, and provocation for provocation's sake have no place in a classroom; reasonable people disagree reasonably. These guidelines can help instructors and students as they work together to fulfill the mission of the University of Florida, which includes the exploration of intellectual boundaries, the creation of new knowledge, and the pursuit of new ideas.

## TITLE IX COMPLIANCE

At the UF, we strive to protect our students, employees, volunteers, and visitors from any form of sexual misconduct, discrimination or violence. These behaviors will not be tolerated and any individual who engages in such conduct will be subject to disciplinary action. UF encourages every employee to be a safe supportive person to anyone disclosing their experience of discrimination, harassment, or violence. Employees (including the instructor) are expected to let individuals who disclose know that the Title IX Compliance Office is able to provide support and information to all parties, inclusive of students and employees, who may be impacted by these events. Responsible authorities (including the instructor) are employees identified by the Title IX Compliance Office that are required to report disclosures of sexual harassment, sexual assault, stalking, dating, and domestic violence. Responsible authorities are notified of this designation by the Title IX Compliance Office and provided training to be successful in this role.

After a report is made the Title IX Coordinator will contact the person who made the report and the person who is reported to have been harmed to follow up with them and provide support. Making a report does not require an individual to move forward with an investigation – it does provide the Office with the opportunity to offer support and information so that the individual can make a safe and informed choice on how they might wish to proceed. There are additional reporting options that you can use to notify UF of prohibited conduct. An individual may choose to make a report to UF and may also choose to make a report to law enforcement. They may pursue either or both options at the same time. They may also choose to report to neither the UF nor to law enforcement. The UF process is independent of the law enforcement or criminal process and the two systems do not communicate. Therefore, anyone desiring to seek a criminal process must file a report with law enforcement.

If you are seeking criminal penalties, you should file a report with the relevant law enforcement agency. A criminal investigation undertaken by the police seeks to determine whether an individual violated criminal law. An individual who is found guilty of such a crime following a police investigation and a trial may be imprisoned.

Incentivized attendance (extra credit for 100%). Life happens pass can be used for attendance. Don't come to class sick. Lecture will go at least an hour with 10-minuteeaks.

### **MAKE-UP POLICY**

Late assignments will be accepted and 10% of the grade will be deducted per day the assignment is late. However, students will have two Life Happens Passes (LHP) which they may use to turn in an assignment late within 3 days of the due date with no penalty. Students should let the instructor know within 24 hours of missing an assignment whether they will turn it in late for 10% off per day or turn it in within 3 days with no penalty and use one of their two LHPs. Please note Honorlock will proctor your exams (quizzes are open book). Honorlock is an online proctoring service that allows you to take your exam from the comfort of your home. You do not need to create an account, download software or schedule an appointment in advance. Honorlock is available 24/7 and all that is needed is a computer, a working webam, and a stable internet connection. To get started, you will need Google Chrome and to download the Honorlock Chrome Extension. You can download the extension at [www.honorlock.com/extension/install]. When you are ready to test, log into Canvas/E-Learning, go to your course, and click on your exam. Clicking launch Proctoring will begin the Honorlock authentication process, where you will take a picture of yourself, show your ID, and complete a scan of your room. Honorlock will be recording your exam session by webcam as well as recording your screen. Honorlock also has an integrity algorithm that can detect search-engine use, so please do not attempt to search for answers, even if it's on a secondary device.

### **GRADE APPEAL POLICY**
