Dear Colleagues,

In accord with the development and current implementation of the S-U Policy for undergraduate courses (<http://undergrad.aa.ufl.edu/for-students/covid-19-and-academic-policies/s-u-grading-and-drop-policy-update/>), **the college will be offering a similar S-U option for graduate courses across all four of our departments.** Note the emergency drop option that is part of the undergraduate policy will not be available to graduate students.

Further details will follow, but the first step in this process is to **determine whether any of our graduate courses should be deemed ineligible for the S-U option.** Requests for ineligible courses should be the rare exception rather than the rule. The list of courses to be excluded from the S-U option must be sent to the Graduate School as soon as possible, but no later than the close of

business on **Monday, March 30, 2020**. Please discuss any requests for courses to be deemed ineligible for the S-U option with your respective department chairs, who will send the request to the Dean for a final decision by the March 30 deadline.

Thank you again for your thoughtfulness as we uphold the integrity of our academic programs while being sensitive to the unique demands being placed on our graduate students and our undergraduate students taking graduate courses.
