Thank you for your ongoing efforts to overcome challenges and develop creative ways of working in new physical and virtual environments.

Forgive the long message. Numerous information items have been communicated via multiple UF, HHP, and departmental channels over the past week. **Here's a few highlights** in case these haven't made it to you yet, or you missed them the first time around.

Academic Affairs

- **Summer B courses are online and Summer B start / finish dates are pushed back 1 week, now beginning July 6, 2020.**

- **Academic Policy and Practice Adjustments**

 - Unless otherwise noted, **these policies apply only to Spring 2020**, and are intended to revert back to their current structure in the Summer 2020 semesters and forward.

- From the **UF Counseling & Wellness Center (CWC)**...
 - **CWC associates are available to Zoom into your classroom** to share mental health-related information and resources. Faculty, and staff may request a tele-reach service by completing a CWC [Outreach Request Form](#) outlining tele-reach needs.
 - The **CWC encourages faculty, and staff to use their COVID-19 resource page** (counseling.ufl.edu/covid19) for helpful information on managing concerns and emotions during COVID-19 and seeking support.
 - The **CWC will provide short-term telemental health counseling for UF students beginning today, April 8, 2020.** Students may contact CWC at (352) 392-1575 to schedule a brief consultation appointment and discuss eligibility (e.g. currently residing within State of Florida) for this service.
- **Graduate Student Appreciation Week** continues through Friday.
