COURSE DESCRIPTION

This course is designed to explore revenue generation in sport. Students will learn foundational sales concepts, including the sales process. Then, students will explore the role of corporate partnership in sport, and the application of the sales process as it relates to developing solutions to achieving partner organization objectives. Students will also explore fundraising, specifically in the context of collegiate athletics and community sport, with a focus on cultivation strategies.

COURSE OBJECTIVES

After successfully completing this course, students should be able to:

- \checkmark Explain the role of sales in sport organizations, and across segments of the industry.
- \checkmark Apply the sales process in a sport business setting.
- ✓ Explain the nature and role of corporate partnership in sport.
- ✓ Evaluate elements of fundraising strategies in non-profit sport organizations (e.g., foundations & college athletic department).

Students will have 2 free absences without point deduction (including group presentations days). After that, Students will have 50 points deducted off their final grade for each class missed. Instructor will randomly check the attendance. <u>Arriving to class after the instructor has started</u> class will be considered an "unexcused" absence.

GUIDELINES FOR ASSIGNMENTS

1) In-Class Quiz (24%): There will be four in-class quizzes and will comprise 24% of your final grade. These will be administered online through the course website and will be proctored through **Honorlock**. The questions will be based on the class materials of every two chapters (if we are learning Chapter 3, the quiz will be asking question about Chapter 1 and 2 only, if we are learning Chapter 5, the quiz will be asking question about Chapter 3 and 4). A makeup quiz must be requested in writing and will require written medical proof. No requests to retake the quiz will be granted.

- **Honorlock** will proctor your exams this semester, allowing you to take them from the comfort of your home. There's no need to create an account, download software, or schedule an appointment in advance. Honorlock is available 24/7, and all you need is a computer, a working webcam, and a stable internet connection.
- To get started, use Google Chrome and download the Honorlock Chrome Extension at <u>www.honorlock.com/extension/install</u>. When you're ready to take your exam, log into the LMS, go to your course, and click on your exam. Select "Launch Proctoring" to begin the Honorlock authentication process, which includes taking a picture of yourself, showing your ID, and completing a room scan. Honorlock will record your exam session via webcam and also monitor your screen. The system has an integrity algorithm that can detect search-engine use, so do not attempt to search for answers, even on a secondary device.

2) Current Sport Issue or Event Group Presentation (16%): Understanding and leveraging current sports issues or events is essential for developing effective revenue-generation strategies. By engaging with real-world examples, students gain practical insights into the industry, allowing them to brainstorm and craft strategies that directly address contemporary challenges and opportunities. This assignment is designed to help students apply their knowledge to real-time situations, enabling them to think strategically about how to capitalize on current trends and issues to maximize revenue potential in the sports sector.

- Students will work in groups of 4 to 5 for this assignment. At the beginning of the semester, each group will select a date to give a 13-14 minute current sport issue or event presentation to the class, followed by a 1-2 minute discussion (minimum 15 minute).
- Each group must find a current issue or event in the sports industry. Useful resources include Street & Smith's Sports Business Journal, Front Office Sports, databases available through the UF Libraries, newspaper such as The New York Times, The Wall Street Journal, magazines such as Sports Illustrated, Forbes, or websites such as ESPN.com, CBSSports.com, and etc.
- The presentation, along with the link(s) or a copy of the original article(s), should be submitted on Canvas by 11:59 p.m. the day before the presentation and must include the following:

a) Summary of the issue/event 15/80

b) How it relates to the topic in the course (the revenue generation in sport) 30/80 For example, including their strategies in ticket sales, broadcasting, sponsorship, CSR, fundraising, merchandising, social media and etc.

- c) Two thought-provoking discussion questions on the topic 15/80
- d) Your own critical analysis/findings to the questions above 15/80
- e) Reference and copy of the original article 5/80
- Failure to submit PPT slide on due date will cause a 20 (25%) points reduction.
- Failure to present on the scheduled date without written notification in advance will lose 75% of the points.

3) *Exams I (15%) & Exam II (15%):* There will be two exams and will comprise 30% of your final grade. Everything discussed in class and in the assigned readings may appear on the exam. A makeup exam must be requested in writing and will require written medical proof. No requests to retake the exam will be granted.

4) Sales Promotion Evaluation Group Project (Written & Oral) (25%):

The purpose of this project is to analyze an organization's past sales promotion or revenue generation works and provide implications for improvements. Each student will be assigned to a group of six or seven. Each group will complete an evaluation of a sport organization's sales plan in which your group is interested. Each group will give a 15-minute presentation. The final paper of the group project needs to be submitted **by Dec. 11th, 11:59pm**. The length of the written page should be at least 20 pages. (A detailed project guideline will be provided.)

- Executive Summary (up to one page) 5/125
- Table of Contents 3/125
- Summary of organization 10/125
- Evaluation of the organization's current revenue/sales generation products 15/125 (e.g., Tickets, Events, Apparel, Media rights, sponsorship, etc...)
- Evaluation of the general industry and competitors' current revenue/sales generation trend and strategies 20/125
- Critical group analysis 35/125 (Whether your organization should adopt or remove the revenue generating strategies or not. Why? Give two suggestions on how to either replicate the competitors' strategies or provide new ideas)
- Other student's participation encouragement (2 questions) 10/125 (either ask questions to the students or bring out questions from the student)
- Presentation Time Management 5/125
- Friday Group Work 22/125
- Total 125

5) *Peer evaluation (2%)*: All team members should submit peer evaluation regarding group final group project. The form will be uploaded on the course Canvas and should be submitted after the final group presentation (**by Dec. 4th, 11:59pm**). A lack of contribution to your team project will significantly affect your grade.
