## **COURSE DESCRIPTION**

This Patient Health Education course is focused on addressing practical issues health professionals face as they strive to provide effective patient, family, and staff education. Topics include, but are not limited to, education in healthcare; application of learning theories to healthcare practice; determinants of learning; compliance, motivation, and behaviors of the learner; literacy in adult client population; socioeconomic and cultural attributes of the learner; learners with disabilities; instructional methods and materials, and evaluation techniques in healthcare education.

## **LEARNING OUTCOMES / COURSE OBJECTIVES**

Upon completion of this course, students will be able to:

1. Identify the purposes, goals, and benefits of patient and staff education, and compare the education process to healthcare practice.
2. Deconstruct approaches to learning and explain how different types of practice and feedback variables can be applied to patient/client teaching.
3. Articulating the health professional educator's role in the learning process with emphasis on the factors that need to be assessed.
4. Integrate the role of the health professional as an educator in health education and promotion.
5. Assess the impact of illiteracy and low literacy on patient/client motivation and compliance with healthcare regimens.
6. Describe how different teaching strategies may be needed to accommodate patients'/clients' beliefs and customs.
7. Implement teaching strategies that can be used when working with patients/clients with sensory, learning, developmental and/or physical disabilities.

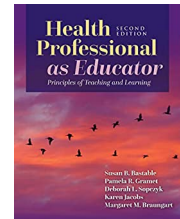
## **COURSE PREREQUISITES**

## **COURSE INSTRUCTIONAL METHODS**

This course uses a combination of assigned textbook & supplemental readings, video lectures developed by Dr. Garcia-Guettler, online student engagement, and discussion, reflection, & application activities. All supplemental readings are available through the course website. UF's Canvas will be the official learning management system (LMS) for this course.

Patient Health Education, HSC4233/6235, is an online course delivered asynchronously. Asynchronous means that you will interact with the course material online, on your own schedule, within a certain time frame that has been allocated for this coursework. With this flexibility comes the demand for tremendous self-discipline and awareness of your work habits. Online education courses can be deceptive in the time required to complete assignments in an exemplary manner by the stated deadlines.

Students commonly underestimate the time needed to complete the assigned readings and assessments within the posted time frames and deadlines. Part of this underestimation stems from the lack of regular face-to-face contact with me and with your classmates. Without this contact, some students seemingly "forget" they are enrolled in a course. If you have never taken an online education course, let me know this is your first online course. I'm here to help but part of my ability to help involves communication from you.

## **RECOMMENDATIONS FOR SUCCESS IN HSC4233/6235:**

1. Take ownership of your education and learning experience. Online courses are easy to ignore, so keep up with readings, video lectures, and assignments.
2. Familiarize yourself with all course due dates - don't wait until it's too late to submit.
3. Complete readings and watch video lectures ***before*** submitting assignments. Doing so will give you a stronger foundation for making meaningful contributions to course discussions and better prepare you for the quizzes and exams.
4. Be an active and engaged participant in class discussions and activities. Plan to be online a minimum of five to seven times each week.

5. Use a word processing program (i.e., Microsoft Word, Google Docs, or LibreOffice Writer) when initially typing your discussion posts and other assignments instead of typing them directly into the Canvas assignment link - this will enable you to save your work in case of any unexpected technical glitches as well as be able to use the spelling and grammar checkers before you submit your work.
6. Inform me whenever (a) a problem related to the class arises; (b) you feel the need to clarify questions; (c) you desire to further explore topics of particular interest.

### **Descriptions of Course Requirements**

#### **1. Course Orientation Assignments (20 points)**

- a. Canvas and Zoom Photo/Image/Graphic Upload to personal profile (1 point)
- b. Personal Introduction & Peer Replies (5 points)
- c. Syllabus Quiz (10 points)
  - The course syllabus is considered THE mutual agreement between me (the course instructor) and you (the student). The Syllabus Quiz is to ensure that you fully understand the policies, procedures, and expectations of this course.
- b. NameCoach Submission (1 point)
  - NameCoach provides a tool for recording and sharing students' names accurately so that proper pronunciation of one's name can be made.
- d. Honorlock Familiarization Quiz (3 points)

- Honorlock will proctor your exams this semester. Honorlock is an online proctoring service that allows you to take your exam from the comfort of your home.
- This “Familiarization Quiz” is designed to provide you with an opportunity to try/test HonorLock. This way, if any HonorLock issues arise which need attention, it/they can be taken care of prior to your Midterm Exam.

## **2. Readiness Assessment Quizzes “RAQ’s”**

**(Modules 1-11; 11 @ 5 points each with 1 drop permitted = 50 points)**

- Modules 1-11 RAQ’s are brief, open-book quizzes based on the reading assignment for that module. These quizzes may include multiple-choice, true/false, and/or short answer type questions. RAQ’s are designed to be completed prior to the corresponding module’s Discussion Forum so that your comprehension of the readings will be demonstrated in your posts.

## **3. Discussion Forum “DF’s”**

**(Modules 1-11; 11 @ 8 points each with 1 drop permitted = 80 points)**

- Discussion forums offer an intellectual, analytical, and social space that can foster personal connections in our online environment. Discussion forums improve student learning by providing opportunities for students to collaborate and learn from each other. Be sure to review the DF grading rubrics prior to submitting your posts. Supplemental DF post information provided in Appendix A.

## **4. Student-Generated Exam Questions (SGEQ’s)**

**(Modules 1-11; 11 @ 3 points each with 1 drop permitted = 30 points)**

- Developing exam-like questions based on your assigned readings helps to improve your understanding of the course material and assist me in evaluating and assessing your learning of the module content. For these assignments, upon the completion of each module, you will submit one (1) multiple choice, one (1) true/false, and one (1) short answer/essay question with their corresponding answers. 20-25% of questions on each exam will come from SGEQ’s. Specific formatting guidelines are provided in Canvas.

## **5. Case Studies (CS’s) (4 @ 25 points each = 100 points)**

- Case studies are assignments where a specific situation is analyzed, in our case real-life patient health education scenarios, and then we research and explain how the elements and complexities of that situation relate to theory. By applying your knowledge of theory learned in various modules, you will derive solutions to problems and/or recommendations for future action related to these situations.

## **6. Fact Sheet Project (100 points)**

- You will research a specific health condition and create a fact sheet designed to serve as a teaching resource for health educators or a learning tool in a population in a specific stage of development. Your fact sheet will be unique (your own creation, based on appropriate, credible sources that are correctly cited) and address a specific health condition or issue. More specific information about designing your Fact Sheet, including requirements and potential resources can be found within the “Fact Sheet Project” link of our HSC4233/6235 course website.
- Accessibility to the Fact Sheet Project will begin after Module 05 as prior knowledge from Modules 01 to 05 is necessary to begin and complete this project.

## **7. Exams (Midterm Exam = 150 points| Final Exam = 150 points)**

- There will be 2 non-cumulative, open-book, open-note exams for this class: The Midterm Exam will cover Modules 1-5 and the Final Exam will cover Modules 6-11. Material presented on each exam is formulated to assess your comprehension as well as applicability of information learned. Exams will consist of questions using various formats such as: multiple choice, true/false, matching, short answer, & essay.
- Exams will utilize the Honorlock proctoring service. Honorlock is an online proctoring service allowing

you to take your exam from a remote location. You **do not** need to create an account or schedule an appointment to complete an exam with Honorlock. Honorlock is available 24/7, and all that is required is a computer (laptop, desktop, or Chromebook) that can run a Chrome browser, a working webcam/microphone, your UF-ID or government issued photo ID, and a stable Internet connection.

- Honorlock proctoring service will require you to download their extension via Google Chrome at <http://www.honorlock.com/extension/install>.
- Honorlock records your exam session through your webcam, microphone, and a recording of your screen. Honorlock also has an algorithm that can detect search-engine use, so do not attempt to search for answers, even if it's on a secondary device.
- If Honorlock detects potential behavior that the instructor has identified as prohibited, it will flag that point in the recorded exam session for your instructor to review after your test session. If that behavior repeats or is significant (for example, a new face appears in the background, other voices are detected, or it detects other internet browsers being used), a live exam proctor may pause your exam and begin a chat conversation in a window over the exam to ask you about the noted behavior.
- Honorlock support is available 24/7/365. If you encounter any issues, contact them through live chat on the [support page](#) or within the exam itself.

#### **8. Extra Credit (up to 10 points)**

- There will be extra credit opportunities provided throughout this semester. Information about these opportunities will be posted in Canvas.

#### **Late Work Policy:**

- Due dates/times for all course requirements are posted in Canvas and set to Eastern Standard Time (EST). - Late submissions will be accepted but will be subject to a penalty. For each day (24-hour period) a course requirement is late, the grade will be reduced by 20% of the total possible points for that assignment. For example, an assignment worth 10 points submitted within 24 hours of original deadline will receive a maximum possible grade of 8 points, and an assignment submitted within 48 hours will receive a maximum possible grade of 6 points. After 3 days (72 hours; 60% off), late assignments will no longer be accepted and a grade of zero (0) will be assigned.
- To clarify and exemplify, a course requirement with a deadline of 11:59pm EST, means 11:59:00pm or 11:59pm and zero seconds. If the submission time on Canvas displays 11:59pm EST but also displays "Late" then the submission was made at some point between 11:59:01pm (11:59pm and one second) and 11:59:59pm (11:59pm and 59 seconds). With that said, if Canvas displays the submission is "Late", then it is late, and the late penalty will be applied accordingly.
